

Pacific Life Product Training on RegEd

This guide will walk you through the steps required to complete the Pacific Life Product Training on the RegEd website.

Step I

Complete the Pacific Life Product Training by clicking the link below to get to the RegEd website:

Once you are at the site, log in from the box in the upper right-hand corner. If you haven't registered at the site before, click the **Sign Up** button and complete the required form.



Step 2

At the main Producer Status page, you will be presented with the Pacific Life Product Training. If there are any outstanding state insurance requirements, they will show above the carrier-specific product training.
